About the ADN Program

Registered nurses administer nursing care to ill and injured persons. The majority of jobs are in hospitals and clinics, but opportunities are also available in public health, education, and industrial settings. As the population ages and the nursing workforce nears retirement, there is a significant demand for nurses regionally throughout California.

Because of the serious responsibilities of registered nursing, and to fulfill the legislated mandates of the California Board of Registered Nursing, the SRJC ADN program is a very rigorous, sequential, four semester nursing education which requires full-time attendance to meet the required program hours and course student learning objectives. The successful completion of this major entitles the student to an Associate of Science Degree in Nursing, and eligibility to take the NCLEX-RN, the professional state licensing examination to become a registered nurse.

Preparing to Apply for the ADN Program

- Attend a **Counseling Pre-Nursing Information Meeting** (dates are posted on the SRJC Counseling website) and consult with a health sciences counselor at the SRJC Counseling Department prior to beginning the program prerequisites or to have individual transcripts or coursework evaluated.
- All course substitutions must be reviewed by SRJC Admissions and Records. Program requirements can be subject to change and students are strongly advised to consult with their counselor regarding all requirements. The ADN administration/admissions does NOT evaluate individual transcripts prior to application.
- Prepare for and take the TEAS test, a copy of the unofficial TEAS score must be included with the application.
- **It is the applicant's responsibility to ensure that the application is complete.** ADN admissions will not evaluate the application for completeness prior to screening.

Application Procedure

1. The ADN Program application is a **separate, hard copy application process**. All completed applications include:
 - a. All sections of the application completed and signed;
 - b. Unopened, sealed official transcripts and/or printed SRJC unofficial transcripts;
 - c. A copy of unofficial TEAS test results (See TEAS Requirements on page 4)
2. ALL sections of the application should be completed and submitted for consideration for admission. Incomplete applications are designated ineligible for consideration for admission.
3. Applicants will be notified via email of the status of their application **on or before June 15, 2027**. Any changes in contact information must be reported to the ADN Admissions and Records Evaluation Specialist, Mrs. Donna Green, via her email at dgreen@santarosa.edu. Please do not call or email the Health Sciences Department or Mrs. Green for application status. **If you wish verification that your paperwork was received, please mail your application by certified mail with a return receipt or hand deliver to the ADN Administration Office and confirm it is date stamped as received.**

ADN Admissions Selection Process

The provisional admission of ADN students is based on the completed application, the Community College Chancellor's Office qualification screening criteria, student space availability, and random lottery results.

1. For all applicants, qualification screening for admission will be based on a probability of student success score. The score will be determined by a formula using the following four criteria:
 - a. Overall College GPA for the past five years (note: if less than 24 units have been completed in the past five years the full college GPA will be used)
 - b. GPA in English 1A (or equivalent course) which must be completed prior to applying for the nursing program.
 - c. Overall GPA within the Core Science prerequisites (anatomy, physiology, and microbiology). Statistical weighted points are deducted for each Core Science repetition.
2. If there are more qualified candidates than 60 student spaces for each semester, all screened candidates with **a probability of success score of 80%** will be selected for provisional admission by a randomized lottery.
3. Completion and documentation of all prerequisites is verified by submitted official college transcripts from non-SRJC institutions or a copy of unofficial SRJC transcripts. *"In Progress" grades WILL NOT be accepted.*
4. All required prerequisites must be completed with a grade of "C" or better.

TEAS Testing Requirements

In addition to completion of course prerequisites, all provisionally accepted applicants must meet eligibility requirements for admission that includes completion of the current version of the ATI TEAS exam with a score of 62% or higher.

- With this application, an unofficial copy of the first current version of TEAS 7 test taken must be submitted.
- If qualified and selected by the random lottery, all students will be required to request their official TEAS score from ATI to be sent Mrs. Donna Green.
- Students who achieve a probability of success score of 80% but submit a TEAS score of less than 62% with their application will still be included in the lottery, however if selected will not be eligible for provisional admission until remediation is completed and a score of 62% or better is achieved with the next TEAS taken. Remediation must be completed in compliance with the offered contract terms which will include specific instructions on how to improve the TEAS predictor. There must be 6 months between TEAS testing taken to remediate scores below 62%.

Provisional to Confirmed Admission

Students selected by the lottery and accepted with provisional admission must satisfy ALL additional requirements to confirm admission space for their selected semester start by the stated deadlines indicated in the provisional admission packet. Because of area hospital policies, students who are provisionally accepted are **required to have all health requirements met, including full immunizations, a clear background check*, and a clear drug screen** prior to acceptance into the program. There are no exceptions to this policy. Hospitals have the right to refuse students placement if unvaccinated, demonstrate drug use, or with criminal convictions. Students who are restricted from area hospitals will not be accepted into the ADN program because course/program objectives cannot be met. Please refer to the Health Requirements and Background and Drug test policy on the ADN website for further information.

Helpful Information for ADN Program Applicants

The SRJC Associate Degree Nursing Program has been approved by the California Board of Registered Nursing, and prepares the student for entry into the practice of professional registered nursing. Students receive clinical experiences in a variety of clinical facilities and community agencies throughout Sonoma County.

The successful completion of this major entitles the student to an Associate of Science Degree in Nursing, and eligibility to take the NCLEX-RN, the professional licensing examination to become a registered nurse.

It is **strongly advised that all applicants attend a Counseling Pre-nursing Information Meeting** and consult with a health sciences counselor prior to beginning the program prerequisites or the application process. The evaluation worksheet is an advising tool only. Program requirements are subject to change and students are strongly advised to consult with the nursing department regarding all requirements.

Registered nurses administer nursing care to ill and injured persons. The majority of jobs are in hospitals and clinics, but opportunities are also available in public health, education, and industrial settings.
